EPIC EMPIRE off slowly, stalked the pace three wide, rallied to gain the lead in early stretch, then drifted in at the eighth pole and drew off. UNBRIDLED'S GUN reserved along the rail, rallied to take over on the far turn, then was being outfinished when steadied from inside EPIC EMPIRE at the eighth pole. AMAZO'N outrun early, passed tired rivals for the show. WYNN'S MESSAGE rated off the pace, raced four wide around the far turn and tired. MAGIC FORMULA set the pace off the rail to nearing the quarter pole, then faltered. GENERATION SPEED chased the pace into the far turn, then faded. COMMANDER BOND was done early after breaking slowly and eased in the stretch run. There was a stewards inquiry and the rider of UNBRIDLED'S GUN lodged an objection against the rider of EPIC EMPIRE for alleged interference at the eighth pole. The stewards determined the incident had no effect on the outcome and the claim of foul was not allowed.
