WICKED WOMAN OF NY set a pressured pace inside and just lasted under steady encouragement. R BROWN SUGAR was bumped inward and into Pink Gloss soon after the start, gave chase inside, eased out a sixteenth away and continued her efforts to get place. TAVATA was bumped then bore in to return the exchange soon after the break, pressured the pace two deep through the backstretch, lost some ground leaving the turn then finished well though outfinished for place. MASTER TRICKY was hustled to a short brief lead outside, continued giving chase through the backstretch and finished evenly. CHATTER WINE chased the early pace toward mid track and leveled off through the lane. ENTERTAINING was closest leaving the gate, raced widest on the turn and never factored. DICED N SLICED was shuffled back early and never factored. POWER EXPRESS gave chase toward the inside and proved empty through the lane. SAILING TIME exchanged contact with Pink Gloss early, gave chase off the rail then faded leaving the turn. PINK GLOSS was severely pinched back and forced into Sailing Time early then never factored. After reviewing a claim of foul against the rider of the third place finisher, the stewards disqualified Tavata and placed her last for instigating the debacle leaving the gate.
