HOBO RIDGE reserved racing along the inside, eased three wide on the far turn, rallied to engage CHARLIE IN CHARGE in the stretch, then duelled with and just edged that rival to the wire. CHARLIE IN CHARGE chased the pace, moved to gain a slim lead leaving the quarter pole, responded when challenged by HOBORIDGE in early stretch, then duelled with that one to the wire and just missed. FRANKLINPARK unhurried early, was racing four wide when steadied outside TELITLIKITISCOACH on the far turn, then rallied for the show. GRAD STUDENT allowed to settle, saved ground and finished willingly without threatening. FARMERS MARKET rated in striking position off the pace, had no response in the drive. BETHEL failed to menace after being outrun early. STATUTORIAL sprinted to a clear lead along the rail, made the pace to the quarter pole, then tired. TELITLIKITISCOACH rushed up three wide on the backstretch to reach contention, then came out a bit when both he and HOBORIDGE eased out on the far turn and faltered. THE RIDER OF FRANKLIN PARK LODGED AN OBJECTION AGAINST THE RIDER OF HOBORIDGE FOR ALLEGED INTERFERENCE ON THE FAR TURN. THE CLAIM OF FOUL WAS NOT ALLOWED.
