SAVANNAH CANON rated off the pace, advanced into contention on the far turn, then rallied under pressure to be up late. MARILYN MERLOT set the pace along the rail to deep stretch but couldn't hold off the winner while clearly second best. AMY 'N JILL well placed racing along the rail, gained the show while no threat to the top ones. PEER REVIEW outrun early, improved her position between rivals in the drive. ARDENT LOVER failed to menace. SARAH SAYS GO rated in striking position off the pace, raced three wide on the far turn and tired. APERFECTLADYDOCTOR was outrun while racing three wide. ISBELL AMBIEL chased the pacesetter into the far turn and faded.
