Footnotes

DOUBLED reserved three wide around the turn, rallied to be just up at the wire. MISS A. J. AVEDON vied for the lead, drew clear entering the stretch and just failed to last. INVOICE unhurried early, angled out for the stretch run and outfinished the others. HANNA'S TUNE outrun early, swung wide for the stretch run and failed to threaten. BURNTHEMUPASHLEY well placed early, tired. ALLENDAR threw her head and hesitated at the start, then was outrun while racing along the rail. DANI MAX wearing a nasal strip, vied for the lead along the rail into the turn, then faltered.
