**Footnotes**

SARAH SUPREME set the pace along the rail, drew away racing into the stretch and remained well clear to the wire under urging. ON LAKE outrun after breaking awkwardly, angled to the outside for the stretch run and rallied for the place. DUTIFUL reserved early, raced three wide around the far turn and closed to gain the show while unable to get to the winner. SUPREME COUNCIL rated off the pace, made a run three wide on the far turn to reach contention, then gave way in the drive. BAY RIDGE TIGER chased the winner into the stretch and tired. CASTLE ROSE chased the pace along the rail, was caught in tight entering the far turn, then faltered. PRIVATE REVIEW (FR) tracked the pace into the stretch, then faded. NORMANDY'S NELL failed to menace. GIANT'S FIRESTONE was not a factor. CRACKER GAL chased the pace for a half mile, then had nothing left.
