PEYTONRELLA chased the pace, rallied to take over at the top of the stretch and drew clear. NO MATCH LADY unhurried early, swung out for the stretch run and rallied to be up for the place. CRYSTAL DREAMS chased the pace along the inside into the stretch and had no late response. PRETTY FACE FAY chased the leaders three wide into the stretch, then weakened. CBT MOCHA MOCHA failed to menace. COUNTY MAYO showed speed along the rail to the top of the stretch and gave way. SEND JOYCE rated off the pace, raced four wide around the turn and tired. TRANQUIL BAY showed early foot and faltered. SYNCHRONIZED FLIGHT showed little after being steadied at the start. MISS MUFFET (SAF) off slowly, was outrun.
