JAZZ SEEKER pressed the pace just off the rail, made his bid around the turn gaining the lead and slowly drew clear through the stretch. CATCH ME prompted the issue from the rail, eased out three wide on the turn and was second best. SURVEYOR advanced along the rail to reach a contending position but lacked a closing bid. STORM SCENE found his best stride late while three wide. NORTHERN CRUISER set the pace on the rail, remained a factor around the turn but gave way in the drive. VALARS within striking distance along the rail, lacked the needed rally. DAILY EXPRESS forced the issue from the inside, failed to respond in the drive. RETRIBUTION was used up after a half, three and four wide.
