**Footnotes**

MISSISSIPPI STORM settled off the pace toward mid track, advanced to the lead inside the three sixteenths pole, dueled clear of the runner-up toward the sixteenth and edged away nearing the wire. DRAFT PICK quickly cleared the field for position inside to rate the pace, was pressured into the final turn and remained a close factor in the upper stretch before yielding the last sixteenth. DYNAMITE DIAMOND, off the pace about the four path, bid into the final turn and finished evenly. LIT DE EDUARDO stalked the pace three wide, gave chase into the final turn but leveled off through the lane. GONE RACIN, six wide the opening turn, raced widest on the turn for home and had no rally. HALLUCINOJENIC bobbled at the break, raced well back inside early, closed four wide through the final turn and finished evenly. JOHN'S PIC was carried out entering the first turn, gave chase toward the inside down the backstretch but had no further response on the final turn. LONG POND steadied at the heels of John's Pic into the first turn then never factored. SILENCE BREAKER angled out into the opening turn and gave chase for a half mile before giving way. JUDGE MARSHALL raced seven wide the first turn and never factored.
