Footnotes

LIL' MISS BRAE, unhurried off the rail, bid angling outward on the final turn, entered the stretch seven wide, continued for the lead inside the sixteenth pole and inched away under the wire. STARLAND QUEEN, off the pace in the three path, progressed while angling outward on the final turn, entered the stretch six wide then outfinished for the win while proving second best. TINY SNIPER rated off the pace off the rail, bid three wide into the final turn, moved to even terms inside the three sixteenths pole, dueled to the lead midstretch but flattened stride toward the wire. RAINYDAYBELLS, off the pace four wide, closed ground through the final turn, came out entering the stretch and leveled off from there. CAMPSIDE took the lead three wide near the seven sixteenths pole, saved ground drawing clear into the final turn, lost momentum while racing close at the inside flank of Tiny Sniper near the sixteenth pole and weakened at that point. SKIP A LONG BELLE chased the pace inside, eased just outside the tiring Rainbow Sweets at the top of the lane and leveled off the remainder. NICKELANDDIMEYA showed no speed well back toward mid track, bid mildly on the final turn but proved empty in the stretch. DONERAILE LASS hesitated a full length at the break. RAINBOW SWEETS rated a slim lead inside the opening turn, gave close chase through the backstretch then faded on the final

turn. FAMILY GIRL stalked the pace two deep while between horses on the backstretch then showed no response on the final turn. The stewards reviewed the stretch run near the sixteenth pole before declaring this race official.
