STORMY ACRE, well reserved to show the way with a long lead, was driven into the lane then taken back in hand late. LIL' BREECHES, off the pace inside, was driven toward the five sixteenths pole though proved no match for the winner and settled for second best. CAPTAIN TEN raced well back of the top two though bested the rest. WICKLIFFE MAN, shuffled back early, made a bid near the rail leaving the five sixteenths pole and passed tired rivals. GENERAL RUTLEDGE, off the pace toward the outside, rounded the final turn about the four path and had no further response in the stretch. SILVER PIONEER, RUNNING GAME and DSPITE ALL MY RAGE were all not factors. CHRIS'S SYMPHONY, off the pace about the three path, gave way after three quarters. IN CONFIDENCE dropped well back.
