RAVENS TERMS stalked the pace inside, advanced three wide around the far turn, swept to command in upper stretch and widened under a drive while continuing on his left lead. PROPER MOVE settled off the pace while racing two wide, advanced between foes around the far turn, rallied through the lane and was just up for the place. GATOR DONE set the pace along the rail, was collared near the eighth pole and weakened. INDIGO MONTOYA prompted the pace two wide and weakened in the lane. JENNY'S EARTHQUAKE broke awkwardly, steadied along throughout the opening quarter, saved ground and improved his position. EBONY failed to menace while racing three and five wide. VIRGINIA AFFAIR saved ground early, raced six wide around the far turn and never threatened. HOUND DOG RED stalked the pace inside and tired around the far turn. BY A LANDSLIDE chased the pace three wide and faltered around the far turn. SIR PRIZE stumbled at the start, stalked the pace three and four wide and was used up after a half.
