Footnotes

NORTH STREET was hustled to the front while making a steady progression toward the rail, rated clear to the five sixteenths pole, was moderately asked from that point, under a drive a furlong later and dug in with willing response to the challenge of the runner-up and third place finishers. DI COLAS GIRL rated close off the rail, bid three wide leaving the five sixteenths pole and held aim through the lane while hanging at the outside flank of the winner. RUNAWAY VALAY, shut off at the rail near the five eighths pole, rated close inside, bid from the five sixteenths pole and dueling close to midstretch before leveling off. SALSA PRIDE settled off the pace toward mid track, made an outside bid from the half mile pole and finished evenly. DOMINIX raced in the three and four paths and had no response on the final turn. EASTER RISING raced outside the first turn then made only a mild bid down the backstretch. ATTEMPTING REENTRY angled toward the rail near the five eighths pole, settled close to the early pace inside but faded after a half mile. SAY WHAT YOU WANT came away awkwardly and was not a factor. CITI DISPUTE was not a factor. MOLINARO MISSION stalked the pace off the rail to the seven sixteenths pole before readily fading.
