Footnotes

HEY U was blocked on the heels of rivals into the first turn, bid leaving the three eighths pole, rounded the final turn at the rail then eased out into the lane to get up and edge clear in late yards. SUMMER WIND BLUES stalked the early pace inside, was pressured to the front toward the three eighths pole, yielded the advantage in late yards and just lasted in place. MOON DROP, unhurried inside, bid off the rail leaving the five sixteenths pole, eased out through the final turn, entered the lane five wide then lugged inward while in a steady advance and just missed place. MRS C, well back inside, bid nearing the three eighths pole, eased outward on the final turn, entered the stretch six wide and finished evenly toward the outside. SIZZLING HOT kept close to the pace three wide, picked up the chase from the three eighths pole but had no further response on the final turn. QUEEN MCRACE raced well back and off the rail. ORMA SHARP settled back off the rail, made a four wide bid from the three eighths pole but lost momentum between horses nearing the final turn. WOO WOO ANN was outrun racing toward the outside. ADAMS LIL MONSTER was in tight between horses the first turn, dropped back from the nine sixteenths pole but gave chase outside on the backstretch before fading on the final turn. SECOND MARKET quickly took over for inside position, rated the pace off the rail to the three eighths pole then faded toward the final turn.
