Footnotes

TRABZON broke out making contact with Plead My Case, immediately picked up the chase just off the rail and came inside the pacesetter deep stretch to get up the final strides. PULPIT'S JET settled well back outside, started a five wide drive from the head of the lane and was just up for place in a strong finish. PLEAD MY CASE, a step slow to break, was urged to the lead off the rail, moved clear into the turn then outfinished in late strides while leveling off toward the wire. POLISH LOGIC showed brief early speed and gave chase to the turn before fading. CANAVERAL CAT chased the pace inside then leveled off drifting slightly out. ALL WORK was hustled along with a slim brief early lead before giving way. HE'S THE KING had a slim brief early lead then steadily faded. LION ON THE RUN gave chase off the rail before fading in the lane.
