FAX AMATIC set the pace on the rail, drew off around the turn then remained clear while kept to a drive. GOLD TEXAN pressed the issue just off the rail and was slowly gaining in the drive. JUDGE MARSHALL prompted the pace three wide, lacked a late response. STORM WITH PRAISE forced the issue along the rail, lacked the needed rally. CAROLINA POWER failed to menace inside. CITITIME DIAMOND was no factor, four wide.
