Footnotes

BOLD PHIL, stranded six wide the opening turn, was urged to contention four wide on the backstretch, saved ground on the final turn, dug in from the head of the stretch to get control inside the sixteenth pole and edged clear toward the wire. **ROYAL ZONE** stalked the pace two deep, came under a drive three wide toward the five sixteenths pole, closed with the winner through the lane, couldn't match strides with that one but was just up for place. **GUNGA DAN** rated a short lead inside, was prompted toward the three eighths pole, caught a pole later, gave chase from there then leveled off in late stretch. **AWESOME BRADY** settled close to the early pace off the rail, was pressured to the front approaching the five sixteenths pole, raced clear into the final turn but leveled off in the stretch. **MEMORABLE DISPUTE**, off the pace and off the rail, bid from the quarter pole though proved empty in the stretch. **CAROLINA BARON** was no factor while saving ground. **SCOOTER TAX**, three wide the opening turn, saved ground leaving the half mile pole then faded nearing the end of the backstretch. **EXCHANGE IN MOTION** was no factor while saving ground. **ACT OF DOMINANCE** bobbled a stride out and never factored. **STAKIN STEWART** raced five wide the opening turn and never factored.
