DYLAN MY VILLAIN rated a short lead off the rail, saved ground contesting the final turn and dug in under hard stretch encouragement to last. OUR CHIEFTAN rated close about the three path, took aim at the eighth pole though hung the length of the stretch. JUDGE MARSHALL was pinched back at the start, settled off the pace off the rail, started a drive into the final turn but leveled off in the stretch. MUNTASIR advanced to the inside flanks of the winner approaching the three eighths pole, steadied at that one's heels leaving the pole and flattened out from there. DEPUTY WANTED, bumped at the start, was not a factor. REAL STAR was not a factor. MAKIN A SUIT broke outward making contact with Deputy Wanted then never factored. DRAGON'S SECRET broke outward and was no factor. THIS CATS MINE saved ground but was through after half. POSTAGE PAID was not a factor.
