RULER KING settled off the early pace inside, eased out from the seven sixteenths pole, rallied to the front a furlong later, drew clear nearing the final turn then wavered paths through the lane while holding well under a steady drive. BATTLE HARBOUR rated back outside, bid leaving the three eighths pole, had aim in the upper stretch, steadied at the heels of the drifting winner near the sixteenth pole, angled in from there and finished evenly. OREO B settled back inside, bid from the seven sixteenths pole, improved off the rail rounding the final turn but leveled off in the lane. AMAZING BUBBA steadied on the heels of Daintree River into the first turn, stalked the pace to the three eighths pole, dueled past that one nearing the final turn, faded at the rail through the stretch and collapsed post race. SILKEN MANNER, off the pace toward the outside, gave chase toward the five sixteenths pole but had nothing further on the final turn. DAINTREE RIVER accelerated to a clear lead to rate the pace inside, came under pressure nearing the three eighths pole then faded toward the final turn. MOONSHINENBISCUITS lost ground into the first turn and was through early. The stewards reviewed a claim of foul against the winning rider, lodged by the rider of the runner-up, though let the result stand.
