**Footnotes**

WHERE'S MY CANDY rated a short lead inside, settled evenly at the rail through the turn and held well with only moderate handling in the stretch. PINK OCTOBER chased the pace outside, saved ground improving her position through the turn and finished well while closing for place. MARIGAN closed to contention three wide nearing the five sixteenths pole, contested the turn two deep, took a slim brief lead leaving the three sixteenths pole and remained a close factor to midstretch before leveling off. MO'S MO'S KITTY, blocked midway on the backstretch, angled widest making her bid through the turn, was bumped out approaching the top of the lane then again at the eighth pole though finished well despite that incident. PURPLE PILLOW, slow into stride, chased the pace while well back, angled outward on the turn making contact with Mo's Mo's Kitty approaching the head of the lane, then again at the eighth pole, angled further to the outside shortly after that point and leveled off the remainder. HEY U chased the pace from the inside, lacked room midway on the turn then finished evenly at the rail. RUNABILITY chased the pace from the inside then faded through the lane. SHE'S PRAISE showed no speed outside. DANCE WITH MINNIE chased the pace about the three path before weakening in the stretch. The stewards reviewed a claim of foul against the rider of Mo's Mo's Kitty, lodged by the rider of Purple Pillow, though found no merit in that claim.
