MISS HAMMA chased the early pace four wide, made a three wide move entering the stretch, drew clear in the final furlong to score the victory under a drive. HOSTILITY set a unchallenged pace on the inside, proved to be no match for the winner late while clearly second best. LEAVN ONA JETPLANE was allowed to settle early, had a mild late rally to get the show award. HOME RUN HITTER was reserved early, raced six wide on the backstretch, made a four wide bid entering the stretch but flattened out. DIAMONDS ONLY was allowed to settle while five wide on the backstretch but had no rally. DEFRERE'S VENTURE raced evenly. CHRISTY T. failed to menace. JUDGE'S APPEAL was not a threat. CUPID SEASON chased the early pace three wide then stopped while being through early. ROYAL PRIZE was allowed to settle while five wide then stopped.
