Footnotes

GO ROSCOE settled off the pace inside, started his bid leaving the three sixteenths pole, assumed control by attrition entering the stretch then just lasted in an all out drive. INALEAGUEOFMYOWN stalked the pace about the three path, bid nearing the quarter pole, was shut off, roughed and carried out leaving the final turn, recovered stride quickly to duel a game second, just missed the win and was probably best here. HEY THERE rated a short lead inside, came under pressure past the quarter pole, bolted across the path of Inaleagueofmyown entering the stretch, quickly recovered a straight path but was outfinished for place while between horses. SWEET HALUCINATION, unhurried inside, bid mildly from the quarter pole. BRADENBROOKE settled back toward mid track, came through the final turn about the four path then leveled off in the stretch. DREAMED, a step slow to break, was through after a half mile. NIFTY ROCKY, just off the early pace, lacked a response on the backstretch. The stewards posted the inquiry to review the incident at the top of the stretch and found no warrant for change.
