SHES UNFORGETTABLE turned back a bid by KITTY CARD down the backstretch, drew clear again around the turn then prevailed under a drive. KITTY CARD pressed the issue three wide, was no match for the winner and all out to hold second. RAVEN'S NEST within striking distance along the inside, finished willingly. FINAL COMMAND prompted the pace three wide, lacked a late response. ESTRELLA DE ROCA tardy at the start, saved ground, lacked the needed rally. RESTINGNSLIGOCREEK never threatened, three and four wide. PRINCESS PUFF off a step slow, made a run four wide down the backstretch, flattened out. LINDA'S CANDY was used up after a half on the rail. GIRL'S ENERGY stopped after a half, along the inside.
