HUGH AND ME vied between rivals down the backstretch, angled to the rail entering the turn, edged clear nearing the lane and just lasted. PERFECT START vied inside early, angled three wide entering the turn, rallied outside through the lane and just missed. RED PETE raced four wide around the turn, continued on his left lead through the lane and rallied for the show. BOREAL FOREST chased the pace from the rail and rallied belatedly. SALT AND LIGHT failed to menace while racing two wide. CHILKOOT PASS pressed the pace two wide and tired in the lane. READY FOR DUTY raced five wide and never factored.
