**Footnotes**

MILLWOOD, unhurried toward the inside, bid nearing the quarter pole, improved on the rail through the final turn, angled three wide into the lane and dug in from there to get up the final yards. PREMIER'S WHINNY, well back inside, bid leaving the five sixteenths pole, improved through the final turn, eased five wide into the lane, finished strong for place and was gaining on the winner. DUTYHONORCOUNTRY rated the pace inside, came under pressure toward the quarter pole, was driven at the midway point of the final turn, drifted slightly outward midstretch, caught late yards and leveled off nearing the wire. I SAIDYESNOMAYBESO rated close inside, gave chase from the five sixteenths pole, was under a drive leaving the quarter, came inside the drifting pacesetter in midstretch but leveled off from there. GARNERED ICE settled off the pace off the rail, bid leaving the three eighths pole, was carried to the four path entering the stretch then flattened stride. KLEINSRIDGE, well back about the three path, passed tiring rivals. LOGANS LIL DEVIL was not a factor. BREWSTER COUNTY raced well back toward the outside, came through the final turn about the seven path and had no rally. SUMMER IN GIZA was kept close two deep, gave chase from the five sixteenths pole then faded on the final turn. MR. DUNKIN settled back about the four path, bid mildly from the half mile pole then faded rounding the final turn.
