Footnotes

DOE prompted the pace three wide around the first turn, moved to the lead two wide leaving the quarter pole and drew off under a drive. PENNIES APPEAL set the pace in the two path, was collared leaving the quarter pole and was no match for the winner while holding well clear for second. COULD BE A RUMOR stalked the pace from the rail, could not match strides with the top two around the far turn but was well clear of the rest. SUPERTRIPP settled off the inside inside and lacked the needed rally. QUICKETIA failed to menace while racing four and five wide. ELECTRIC EMILY chased the pace four wide, had no response nearing the far turn and dropped two wide around that bend. HALF A NOTION steadily faded while racing three wide. SMART RULER raced four wide throughout and never factored. ALMOST A VALENTINE was no factor while racing along the rail. ASPEN BLUSH was outrun while racing three and four wide.
