**Footnotes**

VOODOO'S VISION rated close about the four path, moved to the lead three wide nearing the final turn, lost ground entering the stretch then drew off under a vigorous hand ride. LEGENDARY RIDGE rated close inside, bid off the rail into the final turn, entered the stretch four wide and got up late for place. CHIPPEWA COURT rated close inside, threatened nearing the final turn but leveled off through the lane. HASTA LA PASTA, unhurried inside, bid nearing the final turn, eased out for the drive though flattened stride from there. HANNAH'S DOWERY settled off the pace about the three path, started a drive toward the quarter pole, was carried six wide through the final turn and weakened in the stretch. SNUCK IN FOR FREE raced well back inside and had no rally. STAR OF TAURUS kept close to the early pace about the three path, took a slim lead leaving the first turn then weakened through the final turn. KILLARNY TOWNSHIP, carried out the opening turn, was no factor. I'M FLATTERED lost ground the first turn, settled in unhurriedly two deep and never factored. FLUVANNA set the early pace off the rail, was between horses on the first turn, dropped back past the half mile pole and gave way from there.
