Footnotes

MEADOW MAMA rated a slim lead inside, was pressured leaving the half mile pole, edged clear toward the final turn then just lasted to hold off the closing runner-up. LITTLE MADISON broke in making contact with Tee Kee T, rated just off the pace inside, bid from the five sixteenths pole, eased to the three path on the final turn, finished well and just missed. MAKER'S AFFAIR stalked the pace three wide, challenged the winner leaving the half mile pole and continued a close factor to the head of the lane before leveling off. CALLSFROMTHEPUBLIC rated off the pace toward mid track, gave chase from the three eighths pole, rounded the final turn four wide then leveled off down the lane. MR. MAC'S COLLEEN saved ground off the pace, eased out from the final turn and passed tiring rivals. UPTOWN AMBER rated close to the early pace off the rail, rounded the opening turn between horses then faded down the backstretch. M M POACH stalked the early pace two deep, gave chase from the three eighths pole then faded rounding the final turn. TEE KEE T was never a factor, mostly saving ground, but angled to the outside entering the stretch. MIDSUMMER LADY, five wide the opening turn, kept off the pace outside leaving the half mile pole then faded approaching the final turn. LIVELY CAT DIAMOND, outside, was no factor.
