Footnotes

DOC'S CHOICE prompted the issue three wide, gained a slim lead at the top of the stretch then was all out to last. REPRESENTATIVE pressed the pace just off the rail then in a long drive, missed in a strong effort. SINGIN THE BLUES forced the issue three and four wide, finished strongly through the lane. COVER MY SIX bobbled shortly after the start, moved up four wide, closed with a rush through the stretch. NATIVE REPARATIONS stalked the leaders three wide, lugged out nearing the sixteenth pole and was too late. INCREDIBLE DREAM set the pace under heavy pressure, dug in around the turn, weakened in the drive. UP TO MISCHIEF off a step slow then in tight at the start, was three and four wide within striking distance but lacked a closing bid. BIG ROUGE four wide along the backstretch, dropped to the inside on the turn, checked nearing the sixteenth pole when NATIVE REPARATION lugged out and fell back. I'M FUHR REAL failed to menace four and five wide. SHECKYSHIGHNOTE wide throughout, showed little.
