Footnotes

UNBRIDLED DISPUTE stalked the pace two deep, challenged from the five sixteenths pole, contested at a slight disadvantage rounding the final turn, drifted outward entering the stretch but dug in under determined insistence to take over late yards. TIME FOR ATONEMENT moved clear for inside position to rate the pace, was pressured nearing the five sixteenths pole, contested a slim edge rounding the final turn and dueling gamely to late stretch before yielding reluctantly. GOLD CASING, well back off the rail, eased out with a bid from the quarter pole, entered the stretch in the five path and was along in late yards for show. LYCIAN rated off the pace off the rail, gave chase from the seven sixteenths pole, was blocked nearing the head of the stretch then leveled off late. LONDON TOWN rated back toward the outside, bid from the three eighths pole then leveled off down the lane. EZTOPOINT raced well back off the rail, angled outward with a bid into the final turn, entered the stretch nine wide and had little left. DUG BAR, off the pace toward mid track, made a mild bid saving ground on the final turn. FIRST AND BAY rated close to the early pace inside, picked up the chase leaving the half mile pole but gave way past the five sixteenths. CARINA BAY, well back outside, was not a factor.
