BUY MY COMMISSARY settled off the duel in the three path, quickly advanced three and four wide around the far turn to take the lead approaching the eighth pole, cleared in upper stretch and held sway under a drive. BUBBA BEAR was unhurried inside, advanced two wide around the far turn, steadied off heels leaving the three-sixteenths pole, swung four wide nearing the lane and rallied for the place. PRIMARY ACCOUNT was unhurried while racing three wide, advanced four wide into contention nearing the lane but was out kicked in the stretch. JUST FUHR REAL dueled three wide and tired nearing the lane. ELDER JOHN dueled inside of JUST FUHR REAL while racing in the two path and faltered midway around the far turn. The riders of PRIMARY ACCOUNT and BUBBA CLAIMED foul against the winner for alleged interference near the quarter pole but the Stewards found no reason to alter the original order of finish.
