OCASTA rated close off the rail, bid leaving the five sixteenths pole, angled inside the pacesetter entering the stretch and dug in to get up late yards. ALINA'S LAD rated a slim lead inside, came under pressure from the five sixteenths pole, edged clear past the quarter, lost ground leaving the final turn but dug in with the advantage to deep stretch before grudgingly ceding the win. MOUNTAIN CLIMBER stayed with the pace in the three path, challenged the runner-up leaving the five sixteenths pole then faded through the final turn. KINGSPIEL raced well back and was not a factor. FLYING SPEED steadily lost contact and was carried out by the rider-less Disclosure leaving the three sixteenths pole. GHOSTLY THUNDER raced well back, stumbled over the fallen rider of Disclosure midway on the final turn and was not a factor. DISCLOSURE settled off the early pace outside then broke down midway on the final turn. The stewards posted the inquiry before declaring this race official
