COINED FOR SUCCESS rated the pace inside, was challenged midway through the final turn but dug in determinedly to retain control and recovered clear territory inside the sixteenth pole. VALARS settled back off the rail, started his bid toward the final turn, eased three wide into the stretch and finished a strong second while between horses at the wire. GERRYMANDER, unhurried, bid four wide into the final turn and was closing well through the lane. GUSKA'S GOLD stalked the pace two deep, challenged the winner midway on the final turn and dueled close in the upper stretch before leveling off. UNDAUNTED SPIRIT showed no speed inside, bid off the rail into the final turn but showed nothing further in the lane. KAZ CITY, awkward at the break, gave chase three wide but faded through the final turn. PRIZED CONQUEST was through early and came widest on the final turn. SPIRIT OF GULCH chased the pace from the inside then gave way toward the final turn. TREY'S BAY never factored.
