**Footnotes**

WESTERN RUSH dueled for the early lead on the inside, then was rated back on the backstretch, made an inside bid at the top of the stretch, then drew out in the final sixteenth of a mile to prove best under a drive. CALAMIAMINE dueled for the early lead, made a bid on the backstretch, but weakened in the final furlong, held place. BACA was void of early speed, came wide into the stretch, closed. T. V. SECRETARY had a belated rally on the inside. WINGS TRUE stalked the early pace and made a three wide bid but was empty in the final furlong. BLYTHEWOOD chased the pace four wide but was empty. MY FIRST WIFE chased the early pace then weakened. DEER CREEK LADY was not a threat. CHEROKEE WOMEN was not a factor.
