**Footnotes**

TRES CHIC exchanged contact with Cozy At Midnight leaving the gate, came out to bump Gleaming Rock into the first turn, was blocked from early contention inside, boxed in from the five sixteenths pole to the quarter pole, bid off the rail midway on the final turn, dueled to the lead into the stretch and steadily encouraged to extend that margin. COZY AT MIDNIGHT, brushed early, was boxed at the rail from the five eighths pole to the half mile pole, made her bid a pole later, came under a three wide drive at the head of the lane and dueled clear for place. DEVOUT HOPE, well back inside, improved near the rail rounding the final turn, eased outward through the lane and finished evenly for show. SUCCULENT SCORE rated a short lead inside, came under pressure leaving the three eighths pole, widened into the final turn but was caught entering the stretch and weakened from there. DEVIL DENIED bore in through the front stretch, settled close to the early pace about the three path, gave chase down the backstretch then faded on the final turn. LIMITMENOT angled over to stalk the early pace about the three path, gave chase leaving the five sixteenths pole then faded four wide on the final turn. AFLEET CHILL rated close to the early pace toward mid track, gave chase from the three eighths pole then flattened stride while five wide on the final turn. CAMPSIDE was not a factor. GLEAMING ROCK angled in early, was bumped into the first turn, settled back off the rail and never factored. MUNCH'S RISINGSTAR, jostled early, was kept close two deep to the seven sixteenths pole and weakened from there.
