SPLINDID APPEAL rated a clear lead off the rail, came under pressure from the five sixteenths pole, was driven midway on the final turn and dug in determinedly through the stretch to last. RUTLEDGE STAR settled back toward mid track, bid nearing the five sixteenths pole, loomed a close factor three wide through the turn and while outfinished for the win, lasted in place. FORBES settled well back of the early pace off the rail, made his bid angling outward through the final turn, entered the stretch six wide, closed of his own initiative through the lane and finished well. AIN'T JOKIN AROUND stalked the winner off the rail, had aim leaving the five sixteenths pole and was a close threat to late stretch before leveling off. GOLD STANDARD broke in,settled back off the rail, bid nearing the five sixteenths pole but proved empty in the stretch. UNSHATTERABLE was kept close to the early pace inside, raced boxed at the heels of Ain't Jokin Around past the five sixteenths pole then faded at the rail rounding the final turn. FOREST TANGO raced well back saving ground, was not encouraged after the opening half mile and vanned off post race.
