ALLAPATTAH hugged the rail, dueled with the winner, finished gamely but was out finished the final sixteenth of a mile. STORMIN MIKI saved ground and failed to be a menace while best of the others. SPUNKY MONKEY , shuffled back soon after the break, circled the turn and was outrun. VERA LYNN COLLINS was outrun. ECHO OF NARCISSUS briefly chased the pace, saved ground on the turn and gave way.
