Footnotes

LITTLE MISS KISSES maintained the lead under a firm hold inside, contested the rail through the final turn, came out abruptly making contact with Shesgoinghollywood in the upper stretch then dug in from there to edge clear. SHESGOINGHOLLYWOOD stalked the pace off the rail, moved to near even terms approaching the three eighths pole, contested the final turn, was bumped in the upper stretch and finished up evenly. CENTRIPETAL MOTION, unhurried inside, started a drive leaving the three eighths pole, had close aim at the sixteenth though leveled off the remainder. CHIPPEWA COURT settled off the pace off the rail, eased out through the final turn, entered the stretch four wide and leveled off from that point. HOLY STONE showed no speed inside and offered no rally. LEGENDARY RIDGE rated off the pace four wide while between horses, started a drive from the three eighths pole, entered the stretch five wide and leveled off. HANNAH'S DOWERY was not a factor and raced wide on the turn. PROSECCA, off the pace five wide, gave way leaving the final turn. After posting the inquiry, the stewards reviewed a claim of foul against the winning rider, lodged by the rider of the runner-up, for interference in the upper stretch and subsequently disqualified the former for making contact with the latter in the upper stretch.
