**Footnotes**

WILDERNESS CALL press the pace, gained a slim lead in the upper stretch, lugged in mid stretch briefly then drove clear. BONNY GO LIGHTLY saved ground, lugged out mid stretch crossing in front of CLOUD SURFER then was second best. BETTER N PEARLS dueled for command early, gained clear down the backstretch, altered out and steadied in mid stretch and fell back. CLOUD SURFER brushed the gate at the start, forced the pace three wide, checked in mid stretch when BONNY GO LIGHTLY crossed in front of her and never recovered. HANAILEI BAY forced the leaders three wide, lacked a late response. SANDIFOSS stalked the pace four wide, failed to respond. RUBY JANES GIRL off a step slow and squeezed back at the start, trailed throughout. The rider of CLOUD SURFER claimed foul against BONNY GO LIGHTLY alleging interference in mid stretch. The Stewards reviewed the video tape replays and agreed disqualifying BONNY GO LIGHTLY from second and placing her fourth.
