Footnotes

CAMBRIA QUEEN was boxed at the heels of Congressionalaffair just inside the five eighths pole, slipped through at the rail leaving the nine sixteenths, rated the lead to the final turn, came under pressure from the three sixteenths pole and dug in under steady encouragement to fend off the runner-up. HUNKA'S VICTORY stalked the pace six wide down the backstretch, bid passing the three eighths pole then drifted out while leveling off through the stretch. HERRICANE JO stalked the pace three wide, came under a drive from the three eighths pole, continued close chase through the final turn then weakened in the stretch. DENALI BULLETTE, unhurried inside, eased to the three path on the final turn but had no rally. CONGRESIONALAFFAIR dropped back from the early lead on the opening turn to stalk the winner through the backstretch, chased that one from the quarter pole then weakened in the lane. DISCO DIVA, four wide the opening turn, was not a factor. SNUCK IN FOR FREE was outrun in the three and four paths. RAGABASH and QUEEN OF ALL CATS were not factors.
