Footnotes

SOUL QUEEN stalked the pace two wide, took the lead near the quarter pole, quickly drew clear around the far turn and widened under moderate left-handed urging while continuing on her left lead in the lane. BELLE OF CAMDEN stalked the pace three wide, could not keep pace with the winner around the far turn but finished willingly to be clearly second best. IDEAL THOUGHTS set the pace along the rail, was collared near the quarter pole, weakened and held on for the show. BEANOTHERGRUMP failed to menace while racing two wide. DOLLYS AFFAIR was outrun while racing well off the rail. JOLIE ANGE chased the pace inside and tired around the far turn. A claim of foul from the rider of BEANOTHERGRUMP against the winner for alleged interference entering the first turn was not allowed.
