**Footnotes**

SUPER BUGGY turned back a bid by MARIPOSA ROSA down the backstretch, drew off around the turn, held clear under a drive. A SHOT AND A MINT off the pace saving ground, bid four wide on the turn, closed with a rush through the stretch. MARIPOSA ROSA pressed the issue three wide, lugged in upper stretch, steadied then weakened. LOLIBOP forced the pace four wide, dropped to the rail on the turn, checked in the upper stretch and faded. AVRA BANK with the leaders three wide, lacked a closing bid. CHILDHOOD MEMORIES was used up after a half, five wide. SEVENTH PRAYER was used up after a half, five wide. SEVENTH PRAYER made little impact on the rail. There was a Stewards inquiry and objection filed by the rider of LOLIPOP against MARIPOSA ROSA concerning the stretch run. Following a review of the video tape replays the Stewards disqualified MARIPOSA ROSA from third and placed her fourth.
