**Footnotes**

CRYSTAL DAWN dueled for the early lead on the inside, drew off on the far turn, then was kept to pressure to prove much the best. SPEEDS THE KEY was settled back early, came wide for the drive, rallied. NORDIC LASS was allowed to settle early, then finished well late for the minor rewards. TRIAL DANCER was reserved early and raced five wide on the backstretch, but was empty in the drive. PRESS BEYOND was rated early, had to check up on the far turn, but had no rally. WILD BARGAIN dueled for the early lead and weakened. AWAYO failed to menace. WILD LINEAR was well placed early and weakened. RECESS IN HEAVEN showed little. TIME TO JAZZ was fractious in the gate, stopped.
