WILDCAT MATTIE advanced three wide around the turn, steadily gained through the lane, took the lead leaving the sixteenth pole and held off a late bid from the runner-up. SHINE FOR ME was out sprinted down the backstretch, raced three wide around the turn, angled further out in upper stretch and finished strongly. AMERICAN SPICE set the pace along the rail and weakened in the lane. DANCNINTHELILLIES chased the pace inside and lacked the needed rally. QUIET SCREAMER chased the pace two wide and weakened in the lane. DIXIELAND BRIDE failed to menace while racing two and three wide. VERO BEACH saved ground and never factored. MOON GLO MAE was outrun while racing five wide.
