**Footnotes**

BANNER TIME engaged in close early chase four wide, contested at even terns three wide through the turn, lugged to the rail while moving clear entering the stretch and opened up with mostly a moderate hand ride. HOLY CANNOLI became fractious in the gate unseating his rider, was pinched back early, chased the pace about the four path, steadied past the three eighths pole, saved ground into the turn, angled out past the three sixteenths pole, entered the stretch in the five path and finished well to get place late yards. LEADEROFTHEVALLEY came in for better position making repeated early contact with Contyden, chased the pace two deep, contested between horses through the turn, came in making sharp contact with Contyden again approaching the head of the lane, resumed his drive into the stretch but leveled off toward the wire. RUNNING RACCOON was fractious in the gate, bothered early on, chased the pace off the rail, steadied past the three eighths pole, eased out through the turn, entered the stretch four wide and leveled off from there. CONTYDEN steadied early, was forced in leaving the chute, bothered repeatedly through the opening stages while pressing the pace inside, pinched back and bumped hard at the rail approaching the head of the lane and made no further effort. MACHO STYLE bobbed at the break and ran well back off the rail.

DOCTOR J. chased the early pace outside, was carried further out from the three sixteenths pole and leveled off in the stretch. PEACE MARCH broke out making contact with Cut In Man, raced well back inside, checked sharply past the three eighths pole to avoid a fallen rival and was no factor. CUT IN MAN, bumped at the start, moved to the outside and lacked speed. SOCIALIZATION set a pressured early pace three wide but broke down passing the three eighths pole. After posting the inquiry, the stewards also reviewed claims of foul against the winning rider, lodged by the rider of the third place finisher, and against the third place finisher, lodged by the rider of unplaced Contyden. The stewards then disqualified Leaderofthevalley and placed him fifth for making repeated contact with Contyden at various places.
