**Footnotes**

YOU KNOW I WANCHA sluggish at the start, made a steady advance along the rail down the backstretch, rallied four wide around the turn, gained the lead nearing the sixteenth pole and drove clear. CAPTAIN LEONIDIS set the pace on the rail with a clear lead into the stretch, dug in when challenged in upper stretch, could not contain the winner while clearly second best. GOVERNMENT BAILOUT advanced three and four wide, bid on the turn but came up empty in the lane. WILD TESTIMONY pressed the issue just off the rail, remained a factor around the turn, weakened in the drive. CRUSADER'S ANGEL prompted the pace three wide, lacked the needed late rally. RUGGED CROSS made little impact, four wide. MARITAL BLISS up close for a half along the rail, tired. QUEEN LOUISA stopped after a half, four and five wide.
