VALID VENTURE settled off the duel in the clear, advanced three wide around the far turn, closed outside and was up in deep stretch. PADRE BRAD dueled along the rail, edged clear in upper stretch and led until the final strides. CAPE SABLE dueled two wide, had his rider lose the whip in upper stretch and weakened. ME THE SEA AND G T lagged in the two path, advanced three wide around the far turn and rallied belatedly. FIRST AND BAY settled off the pace while racing two wide early, raced four wide around the far turn and lacked the needed rally. CANAVERAL DANCER broke awkwardly, was bumped soon after the start, saved ground and had no response. MISTER FIPS (IRE) never factored while racing three wide. FORT APACHE STAR raced four and five wide around the far turn and was outrun.
