Footnotes

LADY BOBCAT CHAMPS chased the leader off the rail and dug in at the outside flank of that one to get up the final strides. SMOKEY FELLA rated the early lead inside, maintained the edge while still in hand through the turn, came under pressure at the head of the lane, held off the winner to deep stretch, was caught nearing the wire and appeared sore upon return. TIME FOR A WINNER chased the early pace outside, angled in to hit the rail past the five sixteenths pole, dug in a close stretch factor but leveled off toward the wire. JOHNNY JOE chased the pace about the four path and finished well at the outside flank of the winner. FAMILY FACTS lacked early speed off the rail, eased out into the stretch and finished evenly five wide. MR. BARRACUDA chased the pace about the three path then weakened from the head of the lane.
