Footnotes

BETTER STEP ASIDE stalked the early pace two deep, moved to the lead inside the half mile pole, was urged clear approaching the final turn then dug in at the head of the lane and was all out to last. MILLWOOD rated just off the pace inside, bid toward the five sixteenths pole, rounded the final turn three wide, was closing steadily down the lane and just missed. UNBRIDLED TUNE, unhurried early, bid outside leaving the three eighths pole, saved some ground on the final turn and finished well for show. LOUD RAVENS rated off the pace about the four path, gave chase leaving the three eighths pole, saved ground on the final turn but leveled out in the lane. KLEINSRIDGE settled back inside, made a mild bid toward the final turn, eased out for the drive but flattened stride. KILLER DILLER raced well back early and never factored. BUBBA DE FRANCE was through early. MR. DUNKIN moved clear to rate the pace inside to the half mile pole, gave chase from there, steadied nearing the quarter pole, faded through the final turn, steadied in tight near the rail approaching the head of the lane and gave way. GUNGA DAN rounded the first turn about the four path, moved to the outside entering the backstretch but was through after a half mile.
