FLATWOOD HANK led throughout on a clear lead and prevailed while kept to steady urging. SHAMSS pressed the issue from the rail, finished well. SPORTY BOY advanced five wide along the backstretch, bid three wide on the turn and finished willingly. MADMAN with the leaders just off the rail, lacked a late response. DELAWARE DIAMOND off a step slow, was six wide down the backstretch, dropped down four wide on the turn, lacked a late bid. CANAVERAL DANCER three and four wide for a half, angled to the inside around the turn, lacked a closing bid. DR. FINNEGAN fell back after a half, three wide. ICE BERLIN within striking distance on the rail, failed to respond when asked. FOR APPEAL tardy at the start, never threatened three wide.
